## EPHA, MH Engineering Signs MoU on the Design Work of the Association's Future Headquarters.

The Ethiopian Public Health Association (EPHA) and MH Engineering signed a memorandum of understanding on October 03, 2012 to launch the design work of the association's long anticipated building complex. The signing ceremony of the agreement took place on the occasion of EPHA staff retreat program in Sodere Resort. Dr Tewabech Bishaw, President of EPHA and Dr Mesele Haile, General Manager of MH Engineering signed the agreement on behalf of the two organizations.

During the signing of the agreement, Dr Mesele unveiled that his company is amused upon receiving such a great responsibility from an organization which has been engaged working on social development programs; which according to his articulation is in line with the organizational value and principle of his company. He underscored that his company will try its level best to execute the task at a relatively measurable cost and faster while maintaining the highest quality standard.

Dr Tewabech, for her part, congratulated MH for being selected, based on the merit of its technical preparedness and level of competency by competing with eight similar firms which had submitted bid documents to EPHA.

The tender for the design work of the EPHA building complex was floated for interested and potential firms to compete for, as per the rule of the Public Procurement Agency (PPA), it was learnt.

It was said that EPHA went through a long journey in order to secure the deed title of the 875 m2 plot of land, around Kebena on competitive lease bid.

## EPHA, WHO, FHAPCO and UNAIDS, Jointly Conducting a National Triangulation and Synthesis of the HIV /AIDS Epidemiological and Behavioral Data in Ethiopia

Based on a memorandum of understanding reached among EPHA, WHO, FHAPCO, and UNAIDS, a triangulation and synthesis of different sources of the HIV/ AIDS Epidemiological and Behavioral data is being carried out to identify key population groups and associated factors, program areas and interventions for the design of appropriate strategies and programs towards the achievement of the MDG-6.

The objective of the project is mainly to triangulate and synthesize the epidemiological and behavioral data in such a way that the synthesized final

data would provide strategic information that guides the multi-sectoral response to HIV/ AIDS in Ethiopia. The findings to be obtained from this collaborative research undertaking are, thus, expected to be used in the prioritization of interventions and revision of SPM II and related strategic documents.

Though there are different data sources which is received as a very positive development, some data sources are presented without any reference to the other sources, and with limited explanations of the meanings behind the figures, it was learnt. For instance, the decline in HIV

prevalence in the country is presented in both the ANC and DHS data. However, the biological and behavioral data are neither triangulated nor synthesized as stated in the project document.

A technical working group is formed to follow up and review the progress of the project and is composed of organizations such as the Federal HIV Prevention and Control Office (FHAPCO), Ethiopian Health and Nutrition Institute (EHNRI), Centre for Disease Control (CDC), WHO and UNAIDS. This grant research work is being carried out by the Addis Continental School of P.H.

### A Consultative Workshop Held on the Preparation of a Reference Book on Reproductive and Child Health in Ethiopia



Held on October 15, 2012, the Half-day long consultative workshop, organized by EPHA with financial support from John Hopkins University, has enlightened a new path to produce the first of its kind comprehensive reference book on reproductive and child health in Ethiopia.

Professor Misganaw Fantahun, who first initiated the idea and is assigned to work as one of the editors of the book, announced that the main objective of the project is to produce a comprehensive reference book for the purpose of training in RH/MCH field of

studies, which according to him, can only be realized by pulling together specialized experts from diverse professional backgrounds. He said all what have been made so far are quite appreciable but lack integration and are extremely fragmented.

In addressing her welcome to participants of the workshop, Dr Tewabech Bishaw, President of EPHA first expressed her heartfelt joy for seeing EPHA taking such a big assignment as the main coordinating body responsible for the production of the reference book on reproductive and child health in Ethiopia that is to be used as a reference material at the national level.

## Enhancing the Joint and Organized Efforts of Professional Associations in the National Response against HIV and AIDS

### Global Fund Support Project – through FHAPCO

A project entitled "Enhancing the Joint and Organized Efforts of Professional Associations in the National Response against HIV and AIDS" has been operational since May 2012. The main goal of the project is to enhance the role and participation of Professional Associations (PAs) in the national multi-sectoral response against HIV and AIDS. The project briefly reviewed the organizational status/ capacity and level of participation of the major professional associations in the overall HIV and AIDS response and tried to develop draft strategies to strengthen their capacity and thereby enhance their organized role and participation in the national response. Accordingly, three major activities were planned with the above objectives in mind namely; stock taking, rapid assessment and consultation/ dissemination workshop. The first two have already implemented.

The inventory of existing professional associations within the country was taken. From this, the PAs which were believed to be relevant for the intervention were selected and briefly assessed by focusing on their constituency base and membership, and scope of work.

The second important activity

conducted was a review of their involvement in the national multi-sectoral response against HIV and AIDS. Consequently, a qualitative research approach through Rapid Assessment Process (RAP) was employed. Document review and Key Informant Interview (KII) were used to collect data from purposefully selected PAs and then the data analyzed based on thematic areas identified. The findings showed that the constituency base touches all sectors of the socio-economy while their scope of work mainly focuses on promoting and enhancing the professional capacity of their members, advocacy for their sectors and direct service provision. Regarding their role in HIV and AIDS related interventions, though limited, the major areas include capacity building, awareness creation, research and publication dissemination, program evaluation policy and advocacy and workplace policy program development.

Along with enhancing the current interventions, improvement of quality of care and sectoral HIV and AIDS program development were seen as potential intervention areas by capitalizing on their wide membership base and existing partnership and networks. Major

gaps and challenges identified include resource constraints, low level of prioritization for HIV and AIDS interventions, duplication of efforts and lack of comprehensiveness and follow-up, as well as fund/donor dependency and the slow growth of PAs.

In general, the rapid assessment has shown that Professional Associations have a great potential to play a role in the national response to HIV AIDS despite the fact that actions need to be taken to coordinate their efforts and build their capacity. Some of their major gaps and challenges along with enhancing their potential intervention areas and capacity have been identified. Currently, the project is on its final stage of preparation for the planned consultative/ dissemination workshop to be conducted in order to finalize the draft joint plan of action and disseminate the results of the rapid assessment. The participants will be from Pas that were included in the assessment and other key stakeholders of the project such as HAPCO, Ministry of Health, Ministry of Science and Technology and others.

## AIDS 2012 Ignites Momentum for the Beginning of the End of the AIDS Epidemic Scientific, Political and Community Leaders Call for Collaborative Partnerships and Investments in Research, Treatment and Prevention to Turn the Tide on HIV

The 2011 High Level Meeting on AIDS was a watershed in the global AIDS response. As United Nations Secretary-General Ban Ki-moon stated in his report to the UN General Assembly, .

UN Member States unanimously endorsed the 2011 Political Declaration on HIV/AIDS and its new targets—by 2015 to reduce sexual transmission of HIV and HIV infection among people who inject drugs by half, to increase the number of people on treatment to 15 million, to halve TB-related deaths in people living with HIV, and to eliminate new HIV infections among children.

This year, there is a similar development witnessed. The global AIDS community concluded its biennial conference with a clear sense that the end of the AIDS epidemic is possible with sustained financial, political and scientific commitment. The conference was the most important global gathering in the fight against the spread of HIV/AIDS as well as a unique opportunity for science, community, governments and leadership from around the world to advance the response to the epidemic.

During the conference, important data on the leading HIV/AIDS issues and allow for sharing of lessons learned

among developing and developed countries that will assist in bringing and supporting effective treatment and prevention program to communities around the world were presented and displayed.

As delegates and organizers depart Washington, D.C., where the conference held from 22 July to 27, 2012 under the theme Turning the Tide Together, they understand that though a vaccine or cure is still necessary, scaling up resources and the tools available today has the potential to save millions of lives. Only with coordinated efforts to expand HIV prevention and treatment initiatives, integrate HIV

programs into broader health services, maintain funding, and improve human rights across vulnerable populations will the international community begin to end the AIDS epidemic. “AIDS 2012 has brought delegates together from around the world to Washington, D.C. – with one aim in mind to turn the tide on the HIV epidemic AIDS 2012 drew nearly 24,000 participants from 183 countries. The week-long program featured 194 sessions covering science, community and leadership. “

At the Closing Session, U.S. House of Representatives Democratic Leader Nancy Pelosi said, “The International AIDS Conference is focused on solutions, care, and a cure, bringing together experts, policy makers, and people living with HIV around a single goal: ending the HIV/AIDS pandemic once and for all.

HIV/AIDS is a challenge that knows no borders, and the United States must continue to invest in treatments and prevention at home, while working to restore a future of hope and health to communities around the world.”

## EPHA DHSS Team Partakes at the 2nd Asian Population Association (APA) Conference in Bangkok, Thailand



A team of six experts who are working for the EPHA Demographic and Health Surveillance Sites (DHSS) participated at the 2nd Asian Population Association (APA) conference which was held in Bangkok, Thailand from 26th to 29th August 2012. The conference was organized and led by professors drawn from Mahidol University having attracted more than 650 participants including population study and health scientists from across Asia and beyond.

The conference was served as a platform to exchange and discuss prime and emerging population concerns in the Asian region wherein the EPHA team shared the activities of its university-based DHS sites and Network performance. Conversely, the EPHA team has learned the importance of Personal Digital Assistant (PDA) for the improvement of data quality for DHSS and to establish partnership for future collaboration.

A total of two plenary and more than 100 concurrent scientific sessions were convened; where distinguished scholars presented their findings on cutting edge population and health topics of the Asian region. The most important issues raised during the conference were focused on a priority issues such as techniques of demographic analysis, mortality, longevity and health, internal and external migration, fertility, household marriage and family, data quality and accessibility.

With similar development, it is learnt that two board members and the Project Director of the association attended the APHA annual conference, in USA and the CPHA immunization conference in Canada respectively.

## EPHA, Undertaking Three Operational Researches in North and South Wello Zones

EPHA is undertaking three independent operational researches, focused on Family Planning, Maternal and Child Health and Youth Friendly Services in North and South Wello Zones of the Amhara regional state.

With these operational researches, it is intended to assess and determine the underlying factors that affect the utilization of RH/FP/MCH and YFS in the project areas.

The operational researches are taking place in the specified project sites where the Ethiopian Public Health Association has been implementing

RH/FP project with the support of the David and Lucille Packard Foundation since 2006.

It is the project which has aimed at enhancing the knowledge of Health Extension Workers (HEWs) on family planning service provision and improves capacity of RH/FP leaders and to strengthening the link between Households and Primary Health Care Units for improved reproductive health of women and young people.

Based on the midterm evaluation made in 2010, the project has been scaled up by including new service components

such as Youth Friendly Service (YFS), enhancing the limited knowledge and skill of HEWs in providing long acting FP method, and enhancing referral linkages.

The in-house research capacity of EPHA has recently been making rapid progress, as its research, publication and training unit has been diligently engaged in conducting large scale qualitative and quantitative researches of varying nature for organizations which are working in different public health sectors.

## Cohort 8th of LSI Trainees Graduated



At the graduation ceremony held on December 29, 2012 in the Intercontinental hotel, Addis Ababa, seventeen trainees of the eighth cohort of Leadership in Strategic Information (LSI) program presented and defended their projects, which were focused on the different HIV/AIDS and STIs sub thematic areas, in the presence of Ato Hailegnaw Eshete, Executive Director of EPHA, Nwando

Diallo, CDC representative and other invited guests. Of the 25 public health experts enrolled into the program, 17 of them received certificate awards from the guest of honor, Nwando Diallo of CDC, fulfilling the course standards. It was learnt that the trainees graduated having completed the three successive modules of the training program along with effectively undertaking their respective research projects with the use of secondary data on HIV /AIDS and related topics.

Congratulating the graduates in his opening speech, Ato Hailegnaw Eshete, Executive Director of EPHA disclosed to the participants that researches synthesized with the use of secondary data are vital for decision making at various levels.

According to Dr Fikire Enquselasie, from AAU; School of Public Health, the combination of trainees of the 8th cohort in terms of regional and gender composition was of excellent. The graduates were consisted of health professional drawn from health

I have got Spectrum an excellent tool particularly to the works of the Central Statistics Authority in many ways. We are very pleased for we have received the training the moment we are aggressively working on the national inter-census activity. And I am quite sure we will use Demproj in our inter-census work in order to make population projection over the various demographic parameters.

I had very little knowledge on some of the spectrum models but this training gives me a very practical, comprehensive, and in-depth knowledge on how to use every model in circumstances where I can access basic national baseline data.

**Abeba Andarge, from CSA**

We were very much enthusiastic to get the training on the spectrum model. It was really a golden opportunity for us to explore fresh knowledge and acquire the essential skills that would empower us to stand confident before our students in the university and transfer to them the knowledge. Since the launch of the Department of Population Studies two years ago, Spectrum has been well considered as a course within the curriculum despite the fact that there has been no one fully equipped with the knowledge and practical applicability of the model. That has been highly worrying us. We were planning to find resources and get a capacity building training somewhere in the country or abroad. That's why I affirmed that the training has been a great deal of opportunity for us.

We have also a plan to cascade the training to regional sectoral organizations so as to enable them make scientific projection within their own sectoral and geographical jurisdictions.

**Nega Mihret, from Gondar University Head Population Studies Department**

We came here basically to learn and practice RAPID model which is more relevant to MoFED's interest than the rest. In our annual activity plan, it is stated to produce an informative booklet using the Spectrum model in general and RAPID software in particular. However no one was there who had gone through the process applying the software successfully. The training was up to our expectation and met our point of interest. I can confidently say that I am already equipped with the necessary expertise on the use and applications of the spectrum model. Now we are sure we can do it. In case we need additional technical support, we will contact the future groups.

**Getu Gesso, From MoFED**

I am working in a consortium that works on population, health and environment in Ethiopia which endeavors dealing with integrated efforts rather than a sectoral approach to development. Nowadays, different fields have their own specific model supported software applications. In Ethiopia much has not been done on software models particularly in relation to demographic data to health, agriculture and education. It is a breakthrough for me to have had such practical applications based models. I am really impressed with the models which I have acquired for the last four days on Demproj, Famplan, LIST and RAPID.

The goal of the training was not only to complete the courses and know the application procedures of the spectrum models and go back to our routines but importantly it was to apply the models in order to generate strategic information for macro level decision makers of the various respective organizations that sent participants to the training.

As the spectrum model requires the synergy of efforts of various sector organization and integration among them, am very much delighted to see participants drawn from various organizations namely of CSA, MoFED, Academic sectors, Professional associations...and the like. These organizations can play a pivotal role in the development endeavors and are very appropriate for the training.

On his part, Professor Yemane Beriham thanked all, among others EPHA, John Hopkins University, the FMOH, and School of Public Health of the Addis Ababa University for showing their unreserved commitment and willingness in supporting this priceless project in the progress of the field of reproductive and child health in Ethiopia. 'It has been three years since we commenced discussing to produce a reference book on reproductive and child health in Ethiopia but for various reasons, it has not been materialized until today,' Yemane said. Along this, he underscored the fact that the production of such a large volume reference book requires adequate time and strong commitment which might be cited as one of the reasons for the delay in going ahead. He concluded saying the workshop is an opportunity and an excellent platform to thoroughly discuss on how to produce the book maintaining its standard quality and within a reasonable time framework.

The workshop was attended by 25 resource persons who were drawn from various stakeholder institutions so that they could professionally and technically contribute in the development and production of the reference material as authors, co-authors and editors of the book.

bureaus, hospitals and health science colleges of the regions as well as the Disease Prevention and Health Promotion Directorate of the Ministry of Defense, Ministry of Science and Technology and AAHAPCO. At the graduation ceremony, a group project on monitoring and evaluation plan of VCT program in the Southern Nations and Nationalities Peoples Regional state was presented by Ahmed Nuri, representative of the graduates.

Leadership in Strategic Information training has been provided since 2006 with the aim to develop capacities of the public health sector in using strategic information to improve skills towards need assessment, planning, monitoring and evaluations of the full range of interventions and activities to combat the HIV AIDS epidemic and other public health problems at the sub-national level.

A total of 157 trainees have so far been trained and graduated from the LSI program since it was launched in November 2006 for the first time.
